## Terms and Conditions of Layaway

With Orion's Layaway Program, you pay us a deposit and make two additional payments over time until you have paid for the item in full. Once we have received the last payment, we send you the merchandise.

1. There is a minimum order amount of \$99 and maximum order amount of \$5,000 for a layaway order. (Please note that Build-A-Scope telescopes do not qualify for our Layaway program.)
2. A customer may have only one layaway at a time.
3. You pay the total amount over three equal installments. No product is shipped until payment is made in full. The first payment is due when the order is taken, the second and third at 30-day intervals after that.
4. We accept money orders, personal checks, Orion Gift Certificates, debit cards and credit cards for payment. We can accept a different payment method for each payment.
5. We will send an order acknowledgement email outlining the products on a layaway order and payment due dates. If you do not provide an email address with your order, you should expect to receive the order acknowledgement in the mail.
6. You may cancel your layaway at any time between the time you originally place the order and before the third installment payment is due. If you cancel the layaway within 14 days, there is no service charge, and all of your payments will be refunded to you. If you cancel after this 14-day period has expired, we will return any payments you have made.
7. Our policy is to set aside the item(s) you have ordered until the last payment is received, but if due to our error or circumstances beyond our control your product(s) becomes unavailable, we will give you the option of instructing us to backorder the item(s) for you, or canceling your order altogether. If you decide to cancel, we will refund all of your money.
8. If your second or third installment is not received by the due date we will attempt to reach you and make other payment arrangements. If we cannot resolve the late payment within 14 working days we will cancel your layaway order and refund any payments made.
9. If you add additional item(s) to your layaway order, the subsequent installment payment(s) will be due on the original scheduled payment dates. The amount due will be adjusted to reflect the current order total and payments already received. We will send a new Order Acknowledgment that will remind you of the payment due dates and show the new amounts that will be due.

10. You may pay the full balance due on the order at any time before your third installment is due. We will then ship the order as soon as it is available.
11. If you make your third installment payment by credit or debit card, your order should typically ship the next business day. If you make your third installment payment by money order or personal check, then your order will be delayed for 5 to 7 business days while the check clears the banking system.
12. Residents of Maryland, Ohio and Rhode Island are required to sign and acknowledge Orion's Terms and Conditions of Layaway. Orion will not process the first layaway payment until this is received.
